7. Presentations

Celebrating God's Gift of Life and the Wonder of Life in our Community

- 1) Young Authors Awards
 Students Owen Skarjak, from Father F. X. O'Reilly Catholic School and Mitchell
 Pellarin, who attended Monsignor Lee Catholic School last year, were recognized for
 their achievement in the 2009 OECTA Young Authors writing competition. Their
 winning entries were included in a book published by OECTA.
- St. Dominic Mock G8 and Canoes Mary Puopolo
 When it was announced that the G8 Summit would be held in Huntsville, the
 Canadian government initiated a Model G8 Summit, in which grade 12 students
 from local high schools were invited to play the role of G8 leaders. Students,
 Stephen Fenn, Jessica Kuehn, Taylor Rubinato, Emma Lee, Hillary Elliott, Megan
 Ellis and Jeff Juneau participated in seminars with guest speakers on topics such
 as terrorism, world poverty, climate change and the global economy. One student
 from St. Dominic Catholic Secondary School, Lisa Fleming, was selected to
 attend at the Metro Toronto Convention Centre where the world leaders were
 meeting, and met Prime Minister Stephen Harper and other world leaders, with
 students from around the world.

Last fall Marty Scarlett, construction technology teacher at St. Dominic, and two of his students, was commissioned to construct ten custom hand crafted miniature replica canoes, to be presented to the spouses of G8 heads of state. Vinnie and David spent countless hours before and after and school and on weekends under complete secrecy. They were invited to the Metro Toronto Convention Centre to personally present the G8 spouses with the miniature canoes. They had their picture taken with Mrs. Harper and the other G8 spouses. This was a very memorable once-in-a-lifetime opportunity which culminated in a special presentation at graduation in June. Mrs. Harper sent two of the canoes, carefully packaged in special wooden boxes that were signed by Mrs. Harper with her personal thanks, which were presented to Vinnie and David. They received a standing ovation at graduation.

These experiences show the contribution St. Dominic Catholic Secondary School has made to the local, provincial, national and international community.



- 3) Holy Trinity The Learning Partnership Literacy Award Mary Puopolo Students from Holy Trinity Catholic High School have been participating in The Learning Partnership's Turning Points essay contest since 2002. Over the past nine years there have been over 40 winners from the school six this year including a 1st place winner. Turning Points is a character development and literacy program for students in grades 6-12, in which students read, think, and reflect on their values, and write a narrative essay on a significant event or turning point in their life. Students Charlotte Hengevel, Rachel Vonk, and Brittany Harrison (in the grades 9-10 category) were recognized for their achievements.
- 4) National School Public Relations Association Award Michael O'Keefe Director of Education, Michael O'Keefe, recognized three achievements awarded to staff by the National School Public Relations Association.

Kim Weishar received a gold achievement award for the development of "i-Connect", a transition guide for grade eight students.

Linda McGregor and Darren Schmidt received gold medallions for their development of "Making Good Tracks", a teaching resource guide that was part of a First Nations and Métis initiative. The document has become accepted as best practice by the Ministry of Education, as a model for educators in Australia, as well as other accolades.

Pauline Stevenson accepted recognition on behalf of the Communications and Public Affairs department, for their development a "Ready, Set, Go" kindergarten package, which has also won a Bravo award.

Chair Canning congratulated all of the award recipients and their teachers and staff. Students, staff and their families were thanked for taking time to celebrate their achievements with the Board of Trustees.
