# 1) ShareLife

Bill Steinburg discussed the strengthened partnership of the Archdiocese, Schools and ShareLife that has developed with Simcoe Muskoka Catholic District School Board as well as the more open lines of communication. More schools, staff and students were engaged last year, resulting in \$16,000 being raised, which is more than double the previous year. A plaque of appreciation was presented to the Board. Board Chair Canning noted that the real value in the partnership with ShareLife is the attitude that students will take into their future as adults.

# 2) Student Trustee

Former student trustee Jacob Brodka provided trustees with an overview of his experience serving on the Board of Trustees. Jacob found that it was a life changing learning opportunity to work with his fellow trustees, to represent the voice of students, and to serve on the executive team of the Ontario Student Trustee Association. Jacob walked the trustees through a website he developed to solicit students' views on a range of topics from nutrition to arts and culture. On behalf of all of the Trustees, Board Chair Jim Canning extended best wishes to Jacob for continued success.

## 3) Website

Diane Legg, Director of Communications & Public Affairs; Kevin Kuiack, Principal, and Pauline Stevenson, Web Content Coordinator provided trustees with a tour highlighting enhancement to the Board's website and the school websites, with a refreshed look, and upgrades to the system. Through the communications department, information that is consistent board-wide, such as templates, is provided to the schools for posting on their websites (for example the student trustee posting and application process). This ensures timely and consistent information across the board for all schools, which is imperative to the success of any website.

Kevin Kuiack has been providing leadership to the schools since 2008 in an effort to develop school websites at every school in the Board. Kevin explained the remarkable impact the increased use of the school website has had on the Prince of Peace school community, which includes reducing paper consumption by 80-90%, increasing parent engagement, such as signing up for the schools' e-newsletter and calendar features and keeping parents better informed as they don't have to worry about lost papers and newsletters in student school bags. He also noted that a unique feature to the Prince of Peace community is that parents stationed abroad with the Canadian Armed Forces, can keep in touch with the school on a daily basis.

There was an enquiry as to supporting social networking as a learning tool in the schools. Staff is currently researching social media strategies.
