6. Presentations

Celebrating God's Gift of Life and the Wonder of Life in our Community

1) Catholic Education Week

Sherry Chapman, Coordinator of Religious Education and Chaplaincy Services, provided an overview of Catholic Education Week 2011. Trustees received a copy of the elementary resource kit that was provided to principals by the Ontario Catholic School Trustees' Association. This year's theme is *Celebrating the Spirit* with daily themes of Hospitality; Understanding; Wisdom; Justice and Gratitude. Stephanie Maher, Elementary Curriculum Consultant served on the provincial committee that prepared all of the resources. Part of the focus during Catholic Education Week is to strengthen the partnership between school and parish. During this week, principals are often invited to speak at their parishes. Many schools host activities to which parents and the community are invited to share in the celebration of Catholic Education Week.

2) Monsignor Lee Catholic Elementary School Initiatives and Strategies

Allen Morrison, Manager of Capital Projects, and Peter Moffett of Robertson Simmons Architects Inc., presented a slide presentation of the design for the new Monsignor Lee Catholic Elementary School, in Orillia. This is a replacement school amalgamating Monsignor Lee and some of the Guardian Angels students. The school will be constructed to a LEED silver standard and will be similar to the St. Bernard's replacement school design. Faith elements built into the design such as masonry crosses on two corners of the exterior gym walls as well as a large cross and green glass at the front of the school were highlighted. This will be the board's second school built to new standards that address energy efficiencies, accessibility, technology enhancements, maintenance free materials, and larger kindergarten classrooms, to name a few. The design is a result of consultation with a user group, consisting of Darren Schmidt, Superintendent of Schools, Paul Campbell, Principal of the current Monsignor Lee school, Lu McIsaac, Principal of the current Guardian Angels school, and school and plant services staffs. Funding approval was received on March 9, 2011, from the Ministry of Education.

Clarification was provided that the site plan approvals with the City include portable placements in the future (to accommodate growth). This ensures that significant site alterations to meet municipal standards will not be required when the portables are eventually phased in to the site.

3) Budget and Grants for Student Needs (GSN) Update

Peter Derochie, Associate Director of Education (Business & Finance), walked through the provincial overview slides regarding the 2011-2012 Grants for Student Needs. He then highlighted the revised budget for 2010-11 and the preliminary budget for 2011-12 based on the new GSNs information, noting some assumptions. As more clarification is provided by the Ministry and as the board moves to the second phase of the staffing process, further updates will be provided.

Glenn Clarke, Controller of Plant, was pleased to report to trustees on \$37 million of capital work that will be completed over the next two years across the Board, and over 50 minor projects valued at over \$5.4 million in improvements to schools.

Information will be provided to local media as a means to inform communities about the exciting work happening in their communities to enhance Catholic education.
