Peter Derochie, Associate Director of Education (Business & Finance) walked through the 27 items in the report which identified budget pressures and balancing plan ideas.

Families do have an expectation for the service level that has been established in Special Education, however, trustees commented that with a \$9 million shortfall, consideration will have to be given to reductions in Special Education. The Board can no longer sustain the service level based on the current funding or by drawing on funds from other areas.

2) Report 7.2) 10-2010: Orillia Elementary Project Update

The Board was provided with an outline in November 2009 on the project implementation plan for the new St Bernard's Catholic and Monsignor Lee Catholic Elementary Schools in Orillia. The report that was included with this agenda provided the Board with an update on the design developments and project roll out.
