# 1) Report 6. 1) SP-04-2013: St. Joseph's Catholic High School – Tender Award

Tenders for the school construction were issued to the Board approved pre-qualified General Contractors and three submissions were received at tender closing on June 27, 2013. One submission was non-compliant. The Board's project architect and Plant staffs have reviewed the bid tender submissions and it was determined that the low bid contractor, Monteith Building Group Ltd. submitted an acceptable bid. The total St Joseph's Catholic High School retrofit project cost is funded from the Ministry of Education's School Renewal allocation with \$1.34m being assigned to the 2012-13 year budget and the balance of \$1.62m from next year's allocation. This will leave a balance of approximately \$2.3m for other projects next year. There is no requirement for approval from the Ministry of Education. A building permit is required for this project and a conditional permit was issued by the City of Barrie that day.

Recommendation: That the Board award the contract of the St

Joseph's Catholic High School retrofit project to Monteith Building Group Ltd. at the tendered price of \$2,428,000.00 plus taxes,

subject to municipal approval.

Consensus of the Board of Trustees was obtained for approval of the recommendation.

On behalf of the Board of Trustees, Chair Ferguson advised that they look forward to offering more learning opportunities at St. Joseph's Catholic High School.
